3. Additional terms and definitions for the Transaction to which this Confirmation relates are as follows:

Spot Exchange Rate A: Means (i) the price in the Spot Market for one or more actual foreign exchange transactions involving the Currency Pair A (or cross-rates constituting such Currency Pair A) as determined by the Calculation Agent or (ii) if specified, the price observed from Settlement Rate Option A involving the Currency Pair A (or cross-rates constituting such Currency Pair A).

Spot Exchange Rate B: Means (i) the price in the Spot Market for one or more actual foreign exchange transactions involving the Currency Pair B (or cross-rates constituting such Currency Pair B) as determined by the Calculation Agent or (ii) if specified, the price observed from Settlement Rate Option B involving the Currency Pair B (or cross-rates constituting such Currency Pair B).

Spot Exchange Rate C: Means (i) the price in the Spot Market for one or more actual foreign exchange transactions involving the Currency Pair C (or cross-rates constituting such Currency Pair C) as determined by the Calculation Agent or (ii) if specified, the price observed from Settlement Rate Option C involving the Currency Pair C (or cross-rates constituting such Currency Pair C).

Spot Market: Means the global spot foreign exchange market, open continuously from 5:00 a.m. Sydney time on a Monday in any week to 5:00 p.m. New York time on the Friday of that week.

Barrier Options Disclosure: The document entitled "Barrier Options Disclosure" previously provided to you is incorporated into this confirmation by this reference and made a part hereof. Additional copies of this document are available on request.

Condition on Exercisability: This Currency Option may be exercised or deemed exercised only if ALL conditions are met: (i) the Spot Exchange Rate A from the Settlement Rate Option A at the Expiration Time on the Expiration Date is **[ABOVE]/[BELOW]** the Strike Price A, (ii) the Spot Exchange Rate B from the Settlement Rate Option B at the Expiration Time on the Expiration Date is **[ABOVE]/[BELOW]** the Strike Price B and (iii) the Spot Exchange Rate C from the Settlement Rate Option C at the Expiration Time on the Expiration Date is **[ABOVE]/[BELOW]** the Strike Price C. In any event, the party obligated to pay the Premium must pay it on the Premium Payment Date and in no event will all or any portion of the Premium be refundable.

Settlement: Unless otherwise agreed, this Currency Option if exercised shall be settled on its Settlement Date by the payment of the Digital Payout Amount by the Option Seller to the Option Buyer.

Notification of event: The Calculation Agent shall promptly notify the other party (or parties if the Calculation Agent is not a party) of the occurrence of an event relating to this Transaction. A failure to give such notice shall not prejudice or invalidate the occurrence or effect of an event.
