Kick Out At The End Event: Means that, at the Expiration Time on the Expiration Date, the Spot Exchange Rate

from the Settlement Rate Option is [CHOOSE greater or less] than the Outstrike Price, as determined by the Calculation Agent in accordance with the criteria for the occurrence of a barrier event set forth in the Barrier Options Disclosure.
